




CRIMINOGENIC NEEDS FOR REINTEGRATION




Evidenced-Based Programming



Research shows that certain areas of treatment show the greatest impact on recidivism rates for inmate populations. Therefore, the following are five major areas of treatment suggestions:

1. Cognitive Behavioral/Life Skills groups (Thinking for a Change)
2. Substance Abuse groups (A New Direction)
3. Job Readiness and Employment
4. Educational programs (Learning Center concept)
5. Housing & Community Reintegration Planning

Hillsborough County Treatment Flow

Assessment

Staff complete an LSI-R Risk/Needs Assessment

Track 1

Inmates are placed in a 60 day in-house treatment program based on level of Risk/Need

Track 2

Work Release/Programming

Inmates work full time and participate in treatment groups

Track 3

3AHC/ Day Reporting Programming

Inmates are transitioned to electronic monitoring or Probation Supervision with weekly Aftercare groups

Aftercare

Clients will attend weekly aftercare session while they are on AHC / Day reporting



PROGRAM STAFF

- 1 Program Director
- 1 Case Manager
- 3 Clinicians (LADC)
- 1 Job Development Specialist



Responsibilities of Staff

Program Director - oversees the direct management of all aspects of all inmate programming to include program staff, medical staff, and volunteers. Facilitates, designs and implements programs to ensure compliance with courts and adhere to departmental policy. Serves as the primary contact for all volunteer functions, rehabilitative services, case and treatment records, tours, community liaison, educational and substance abuse programming.

Responsibilities (cont'd)

- **Clinicians** – assesses and treats inmates entering the facility, identifies and facilitates group involvement, formulates treatment plans, collaborates with community resources and programs for referrals, maintains case plans and notes, councils, assists, and provides advocacy for the inmate population.

Responsibilities (cont'd)

Case Manager – provides individual case management for all inmates to include; assessments, liaison for classification, facilitates life skills groups, coordinates contact with local providers and services, makes appropriate referrals for proper placement prior to discharge, coordinates exit interviews to ensure reintegration.

Responsibilities (cont'd)

- **Job Development Specialist** – primarily responsible for the coordination of employment and community services. Facilitates groups on resume writing and acquiring employment, works with local organizations and employers as a liaison for electronic monitoring, work release and community work crews.
